LIBERTY PROJECT

Department of Economics Ball State University

June 2010

PROJECT DESCRIPTION

Phase 1.

Class Project: The Liberty Project is integrated with the Economics Colloquium (ECON 495 section 001). The colloquium is open to Ball State University students and members of the community and is by design a small enrollment class of 5-10 undergraduate. It is meant to introduce the students to ideas of economics and liberty with specific focus in 2010 on selected works of Adam Smith and scholarly commentary on those works. The required readings for fall 2010 shall include: selected portions of Adam Smith's Wealth of Nations and Theory of Moral Sentiments, along with writings about Adam Smith's work by such economists as Vernon Smith, Ronald Coase and James Buchanan.

This colloquium is in its sixth year and is designed to offer students an opportunity to explore economic ideas in a Socratic manner. It also includes interactions with successful members of the local business and professional community. We propose to extend this colloquium in a way similar to our 2010 experience. The Spring Semester of 2011 we would like to invite two scholars of Adam Smith to visit Ball State. The purpose of the visits are to deepen the colloquium participants (and others) understanding of liberty and economics.

Possible scholars for the Spring 2011 are:

- 1 Peter Boettke, Professor of Economics, George Mason University
- 2. Jim Otteson, Professor of Philosophy and Economics, Yeshiva University
- 3. Gary Wolfram, Professor of Economics, Hillsdale College

Phase 2.

Scholar's visit. The focus of the visit of the scholar is to meet and interact with small groups of students. The scholar will meet with the students that organized the visit but also with the students from other economics course and other interested students. The scholar will also present a short public lecture.

Professors Bohanon, Cotet and Van Cott will mentor students in their writing and encourage them to publish the essays (potential outlets for their work: the student paper, the local paper, public policy networks etc). Learning from last year's experience we will require all students enrolled in the fall colloquium to complete their papers by the end of the fall semester. Student writing projects in the 2010-2011 colloquium will be monitored on a continuous basis rather than being end-of-semester projects. Our view is that students learn to write by rewriting, rewriting, and then rewriting some more. Accordingly, we anticipate student projects will go

through multiple drafts. The quality of their final efforts should be of considerably higher quality, and they will have learned a vital input into writing that too often escapes attention in the typical college classroom.

We will keep track of the Liberty Project activities on a web-site to be maintained by students under the supervision of faculty. The web-site will provide information about the activities performed under the Liberty project: the Syllabi of previous colloquia, a short presentation of the speaker, a record of opportunities that students took advantage of through this project (such as participation at IHS seminars, their published essays), and also future opportunities. These records will hopefully spread the information and attract interested students. Offering students the opportunity to integrate in the network of people with same interests would allow them to consider pursuing careers that would advance those ideas. This model allows the students to remain involved after the course ends develop skills of creating, communicating and disseminating ideas about liberty. It also allows the students to link into a larger and ongoing network of people interested in ideas about liberty.

BUDGET

Phase 1.

- Professors' compensation. Professors Bohanon, Cotet and Van Cott will be completing work during the summer to prepare for the academic year course. Additional work, as needed, will span the academic year. We are asking for a \$1500 stipend for each professor to offset the summer effort. Also we are asking for \$500 to defray the costs of refreshment for the E.B. and Bertha C. Ball Center.

Phase 2.

- Scholars' visit. \$2500 all inclusive stipend per scholar. From that \$2500 the scholar will pay for travel, hotel etc. Two scholars at total of \$5000. \$200 for web site development. Incentives for students to publish their work \$800.


